MW8APS Pa 8 or fallen cops

IT WAS a sombre moment when two of the three police officers who died in a car accident in the Eastern Cape were laid to rest at Batlhaping High School in Taung on Saturday.

Sgt Sylvester Tokotshane, 33, and Const Kgathatso Tawo, 34, who are both from Taung and Const Modisagaarekwe Kodisang, 35, from Madibogo village died in a fatal accident last week in Engcobo in the Eastern Cape, while the fourth survived and was hospitalised.

Tokotshane and Tawo were buried in Taung, while Kodisang was laid to rest in his hometown of Madibogo.

Community safety and transport management MEC Mpho Motlhabane, police deputy commissioner Maj – Gen Patrick Asaneng and Greater Taung local municipality mayor Nnyoko Motlhabane were among the high ranking officials who attended the funeral.

In his address to mourners, Motlha-

bane said: "We would like to express our heartfelt condolences to the families of three provincial tracking team members who died due to a motor vehicle accident in the early hours of Tuesday at Engcobo in the Eastern Cape. We also wish a speedy recovery to the fourth member who was seriously injured.

"They died in a battle like true soldiers and we would like to tell the families to rely on God for their strength. These young men served South Africa with devotion, dedication and sheer commitment. They respected the badge and we would like to urge those who remain behind to work hard in the name of these fallen heroes."

Deputy commissioner Maj-General Patrick Asaneng shared the same sen-

Asaneng said the deceased were tracing a suspect wanted on two cases of murder, rape and assault with intent to do grievous bodily harm (GBH) that were reported between 2008 and 2011.

"The members' vehicle collided with a stray animal along the R61 Road near Xholosini village in Engcobo," Asaneng said. "This is an unfortunate and tragic incident in which we lost three of our committed members in the line of duty.

"We will re-assemble other members from the provincial tracking team to go to Engcobo and search for that suspect," he said.

Tokotshane's neighbour, William Kgalagadi, said Tokotshane was like his own son. Kgalagadi further said he would always cherish the moment he shared with him.


Tumelo Manganeng who was a friend to both the deceased said Tawo and Tokotshane loved their job.

He said the two deceased officers were disciplined, dedicated and determined to serve the nation.

NTOMBI NKOSI

THE national Transport Department said it was ensuring that the country's licensing system was "bomb-proofed" mainly because it was a national security matter.

To date, the department has more than 12 million legally licensed drivers

on the eNatis system.

"The number has grown compared to 6 million licensed drivers 10 years ago. There are also more than 12.2 million registered vehicles on the eNatis system.

"The infrastructure used by these vehicles on a daily basis consists of 740 000km of the country's roads," department spokesperson Collen Msibi

Yesterday, the department said it was winning the battle against fraudsters involved in illegal obtaining of licences

at testing centres.

A recent sting operation by the department and Hawks led to the arrest of nine people for obtaining illegal learners and drivers licences in Carnarvon, Northern Cape last week. The suspects appeared in court on Thursday.

"The investigation revealed that the suspects were not physically present at

the DLTC in Carnaryon where the testing was supposed to have happened. Yet they had passed their tests with flying colours and received the illegal licences.

"This operation comes hot on the heels of another sting in Port Elizabeth and in De Aar (Northern Cape) where nine people were also arrested late last year for similar offences relating to fraudulently issued roadworthy certificates," Msibi said.

He said that this anti-corruption operation began in 2005. Consequently, the department had cancelled 37 635 illegal licences and 8241 illegally converted

foreign licences.

"The operation has led to 844 criminal cases being investigated and 188 people arrested including government officials. These cases were pursued with the full support of the Special Investigating Unit and the Hawks," Msibi said.

"We shall refuse to fall and kneel in front of criminals." he said.

"If you want peace, you will get peace," he offered.

selves to fight crime in the country.

"This is an organisation of excellence.

"We will not accommodate anyone who ruins the name of the SAPS.

Sitole said Cele had already given a lot to policing in the country and his clear leadership led to numerous successes in the fight against crime.

"He will lead us into a new dawn, aware of the criminal justice system dynamics and how we can improve in all spheres."

Cele was appointed police minister by President Cyril Ramaphosa, replacing Fikile Mbalula during the recent Cabinet reshuffle.

In June 2012, Zuma fired Cele from the post of national police commissioner and replaced him with Riah Phivega.

ELFAS TORERAL

A KLERKSDORP brothel notorious for harbouring criminals taking advantage of young women and girls will finally be demolished.

The North Gauteng High Court

granted a forfeiture order to the Hawks, Asset Forfeiture Unit (AFU) and National Prosecuting Authority, paving the way for the demolition.

The brothel was raided on several occasions by the North West Hawks and on December 26, 2016, 26 young women and Linda Mbana girls from different parts of the

country were rescued from the property. North West Hawks head, Maj-Gen Linda Mbana said the Priority Crime Specialised Investigations (PCSI) unit of the Hawks that specialises in asset and financial investigations made a submission to the AFU to have the building at Number 5 Viljoen Street in Pienaarsdorp forfeited to the state.

"The PCSI had to gather evidence to prove that the property was used solely for criminal activities in contravention of the Prevention of the Organised Crime Act 121 of 1998.

"The property was raided twice by the Hawks, first in 2016 when 26 women and girls were rescued from the property and again last year when 34 women

were rescued.

"During the raids, two Nigerians were arrested for human trafficking and toy guns. Drugs and money were seized on both occasions." Mbana said.

She welcomed the forfeiture order and said preparations for the demolition of the prop-

erty were under way.

"After a lot of hard work by the Hawks, the AFU and the NPA, the forfeiture order has finally come to fruition. We hope that the demolition of this property will give the community of Pienaarsdorp hope." Mbana thanked everyone involved and encouraged members of the community to report criminal activities in their areas.

Criminal charges for Supra!

SUPRA Mahumapelo's problems are far from over.

On Friday, the North West Health portfolio committee laid criminal charges against the pre-

This came just a day after the Hawks swooped on his office to seize documents relating to contracts with Nepo Dynamics IT.

Criminal charges were also laid against North West Health Department head Thabo Lekalakala, the Gupta linked company Buthelezi Ambulances and finance MEC Wendy Nelson.

The charges relate to the R30 million paid to Gupta linked company Mediosa before any work had been done. It was promised R180 million

Buthelezi Ambulances is allegedly paid millions monthly by the bankrupt health department.

North West Hawks spokesman Captain Tlangelani Rikhotso said: "I can confirm it's a fraud and corruption case. The parties concerned will not be revealed by us at this stage."

There have been calls for Mahumapelo to fire Lekalakala since he admitted to going on a trip to India paid for by the Guptas.

Supra Mahumapelo signed the

However the Mediosa contract was signed by the premier.

EFF provincial legislature member Alfred Motsi called on the ANC to remove Mahumapelo or his party would table a motion of no confidence in him. ANC members have also called for the premier to be investigated for a number of corruption allegations.

Motsi told *Daily Sun*: "Radical economic looting by Supra is a clear reason why he forced North West delegates to the ANC conference in December to vote for Nkosazana Dlamini-Zuma. He wanted to be protected from prosecution.

"The ANC must remove Supra or we'll assist them through a motion of no confidence."

Mahumapelo's spokesman Brian Setswambung said the premier was aware of the case. "Dr Lekalakala is on special leave and investigations are taking place," he
