THIRTY-ONE people have been arrested and charged for public violence, arson and malicious damage to property following violent protests in Koster and Derby.

They will appear in the Koster Magistrate's Court today.

Provincial police spokesperson Sgt Ofentse Mokgadi said the accused were arrested on Thursday and Friday.

They were arrested for cases V) relating to violent community protests that began in Koster on Wednesday and spread to the neighbouring Derby," Mokgadi said.

"It was during the protests that members of the community barricaded the entrance and exit roads to Koster with burning tyres and other objects."

Mokgadi said properties such as a guest house, two houses and vehicles belonging to the Kgetlengrivier mayor, Kim Medupe, were set alight and goods looted.

"Public violence and criminality continued when tuck shops in Koster were looted and when some trucks were pelted with stones while others were set alight in Derby," he said.

Six other people briefly appeared in the Koster Magistrate's Court on Friday and four were remanded in custody until June 1 for bail appli-

Family of deceased says mob justice must end

Community strikes back to stop theft

The family of a man who was kidnapped and beaten to death for stealing a cellphone, baby nappies and a chocolate wants mob justice to end before more lives are lost.

Bongane Mothupi, 28, of Bodibe village near Lichtenburg in North West, was tied with ropes and put inside the boot of a car before he was killed last week.

The group that kidnapped him accused him of stealing from them.

He was assaulted and dumped near his home before he died.

Another suspected thief in the area also died, allegedly also at the hands of the mob, before Mothupi's death.

The incidents of mob justice have raised alarm in the community.

Mothupi's uncle Peter Cisane said his nephew was a troublesome person but did not deserve to die in such a cruel manner.

Cisane, who was left as a guardian to Mothupi and his younger brother after their parents died, said the pain was too much to bear.

"It's like we are part of the statistics now. It's a case of who is next instead of how can we stop this," he said. Cisane said residents in his village had a perception that the police were not doing their job and that's why they resorted to taking the law into their own hands.

"They [police] do arrest people, but the courts release them, mostly because of lack of evidence," he said.

He did not dispute that his nephew might have stolen the goods but said he deserved a jail term not death.

Cisane said the family of the man who instigated Mothupi's death had apologised but he was carrying a heavy burden.

"I do not have money to run this funeral," he said.

North West police spokeswoman Captain Amanda Funani said suspects were arrested and would be charged with murder and kidnapping in court today.

Accused ivory smuggler back in court

A MAN, 23, will make his second appearance in the Motswedi Magistrate's Court today after he was arrested for possession of ivory last week.

Life Ndhlovu was arrested while entering South Africa at the Swartkopfontein border post on May 20.

He made his first appearance on May 22 and was remanded in custody.

North West police spokesperson Lt-Col Amanda Funani said: "At the time of the arrest, Ndhlovu was entering the country from Zimbabwe when Home Affairs and customs officials became suspicious of a backpack that he carried."

Funani said the police were alerted and swiftly stopped him

for questioning.

"Three elephant tusks with an estimated street value of R15 000 were found inside his backpack when the police searched it. He was apprehended after failing to account for the possession," Funani

North West police commissioner Lt-Gen Motswenyane applauded the officials at the port of entry for their vigilance that ensured the accused was brought to book.

She further said the arrest would serve as a warning that cross border crimes would not be tolerated.

The police said it was not for the first time that people trying to smuggle ivory had been arrested at the border post.
