R15m, guns stolen in Mahikeng

CASH amounting to R15m was robbed from the offices of a security company in Mahikeng on Wednesday evening.

Three firearms belonging to security guards at the company's premises are also said to have been taken during the incident.

Police spokesperson Brig Sabata Mokgwabone said a case of robbery had been opened.

"At this stage, no one has been arrested and investigations are under way," he said.

The daring robbery occurred at 8pm when armed men stormed the premises of G4S security company in Mahikeng's industrial

While the number of robbers could not be ascertained, police said nine armed men were part of the attack.

"Five suspects climbed over the wall from the back of the premises and four vehicles were seen driving in through the main entrance. All the men were wearing balaclavas and the registration numbers of the vehicles are not known," police said

What the police have managed to accrtain is that a black Mercedes-Benz, a green double cab Ford Ranger and two Toyota double cab vehicles were used.

"The suspects were armed with handguns and rifles.

"The guards on duty at the offices were held in one room and their firearms, three 9mm handguns, were taken.

"The firearms are a Vector BDH 240 with one magazine and 10 live rounds, a Norinco with no magazine or ammunition and a Girson with one magazine and 15 live rounds," the police said.

However, no guns in the security company's safe were taken during the robbery.

"During the attack, a guard was ordered to open the box room and an amount of R15m was taken and loaded in the suspects' vehicles before they drove away," police said.

One guard was assaulted with a firearm on the head but no shots were fired during the incident.

Copper cable thieves in court

THREE men who were found in possession of copper cable will appear in the Bafokeng Magistrate's Court today.

The suspects aged from 25 to 29 years face charges of illegal possession of copper cable.

Their appearance comes after they were arrested yesterday morning by police officers.

Police said the copper cable found was estimated to be worth R20 000 with a weight of 175.9kg.

Police also discovered stolen property in the boot of the vehicle.

A report released in 2013 found that more than R7bn is lost to copper cable theft each year in South Africa.

With the high demand for copper in Asian nations such as China and India, state owned companies including Eskom, Telkom, Transnet and municipalities are often targeted.

Power utility Eskom said it spent R2bn a yearto replace stolen copper cables.

Telkom also said it lost more than R2bn in less than four years due to the problem.

Two years ago, President Jacob Zuma signed into legislation the Criminal Law Amendment Act.

Under this law, the theft of ferrous and non-ferrous metals is classified as infrastructure crime and carries a minimum sentence of three years.

Several people have been convicted for copper theft this year alone particularly in the Free State and Kwa-Zulu-Natal.

Two months ago, a Mpumalanga man was given a three-year sentence for copper cable theft.

Ngwenya was a teacher at Lekoko Primary School in Mahikeng, North West.

Yesterday, the two accused, Headboy Njokweni (51) and Sfiso Ndawande (50), abandoned their bail application.

Magistrate Ditiro Goliath did not ask the alleged killers to plead.

They will make their next court appearance on 19 January.
