process due to tender irregularities. "The National Road Traffic Act does not give the MEC the power to do what he has done. Furthermore, we believe that the securitisation fee charged by the distributor is excessive and we believe the securitisation of number plate happens on a national level,"

"We do not think that each province

should do its own thing. The company that was appointed for securitisation does not have infrastructure and they have no track record."

Sana CEO Surika Louw said that the system followed will cripple the business and result in job losses.

In her ruling, high court judge Nadia Gutta said that the way the department went about acquiring a service provider fell foul of the law.

Questions were raised on the appointment of Retrone, the appointed company to introduce, securitise and distribute

the proposed number plates.
The court said that the company had not made a significant investment in the industry and comparatively had little experience in the number plate business.

Community safety and transport management spokesperson Thabo Sematle told The New Age that the department respected the court's rul-

"As a department, we respect the court outcome but we reserve the right to apply our minds and get counsel from our legal team," he said. ing on the matter.

"We met the department's legal advisers on Friday and they are busy studying the ruling before advising us on the next step."

ject South Africa Howard Dembovsky Sematle said that it might be too early but options, including appealing the high National chairperson of Justice Procourt judgment, are still on the table.

### Stolen computers recovered

A 35-YEAR-OLD man was arrested and computers worth more than R30 000 recovered in a crime crack-down operation in Moretele village.

Police in Brits and Bedwang conducted a joint crime intelligence

driven operation at the weekend and managed to receive information on the man which they acted

upon.

Lt-Col Pelonomi Makau said: "The suspect's apprehension came after information was received that he was in possession of suspected stolen goods at Moretele village near Bedwang.

"Upon following up on the tip-off, the suspect from Suthelong village in Moretele was found in possession of seven suspected stolen comput-

ers," she said.

Makau said that a further probe revealed that the goods worth R30 000 belonged to the New Horizon College which is in the same building as Makana Creche in Suthelong village.

"The goods were positively linked with a case of business burglary committed last month when nine computers were stolen.

"The suspect is expected to appear

in the Temba Magistrate's Court today on charges of business burglary and possession of suspected stolen goods," she said.

Police officers who made the arrest were applauded for their swift reaction after receiving the tip-off.

Provincial police commissioner Lt Gen Baile Motswenyane commended the officers

and pointed out that cooperation of various units and proper deployment of resources that resulted in the successful arrest will continue to be used in bringing criminals to book.

Committee to hear how police will integrate, strategise processes of 2018 guns amnesty

THE South African Police Service has until tomorrow to reconsider the paperbased system it intends using for the handover process during the proposed firearms amnesty 2018.

The portfolio committee on police will be expecting the SAPS to present how it will integrate the committee's suggestions into the strategy.

The committee suggested to reduce the high number of illegal firearms on the streets using the amnesty as there is a need to integrate information technology systems to mitigate risk and ensure clear and effective record-keeping of surrendered firearms must be built into

the strategy.
Chairperson of the committee Francois Beukman said the intention was to ensure that the firearms were traceable throughout the entire amnesty process, including the point of destruction.

The committee also said that police officers designated to receive these firearms at police station level, must be vetted.

"The committee supports the amnesty but must highlight that this support will be retracted if officers that receive these firearms are not vetted.

There is a need to reduce the risk factor and this can be achieved through vetting," Beukman said.

He said the surrender of firearms at all police stations is also questioned, especially in relation to the trust deficit that exists in relations with the police and some police stations have been flagged for losing many firearms in

recent history.
"We urge the SAPS to rethink this strategy of surrendering arms. Either designate a police station in a cluster or come up with an list of police stations that will be excluded from the amnesty

process.

"The committee needs safe steps and strategy to enhance the amnesty process," Beukman said.

The Police and Prisons Civil Rights Union (Poperu) said there were many illegal firearms roaming the streets.

Poperu spokesperson Richard Mamabolo said this remained a mammoth challenge for both police and communi-

ties need to both confront for common

safety.
"Throughout our country, violence remains at an alarming rate and it is reported that gun-related killings remain the leading cause of death," Mamabolo said.

He said despite the minister of police's commitment to speed up processes for the registration and control of firearms, they urge communities to work closely with law enforcement agencies in reporting those who might be concealing fire-

"It is only through our joint efforts that we can reduce these regrettable killings among ourselves," Mamabolo

As of March 2015 there were 1.8 million licensed civilian gun owners in the

country which means out of 100 people, three own a gun.

Just more than 3 million firearms are registered to civilians.

"The majority of guns are legally manufactured, all illegal guns were once legal before being diverted to the illegal pool of weapons in South Africa,
