COMMUNITY safety and transport management MEC Mpho Motlhabane said sexual offences in the province were a concern.

Mothlabane said the department would build a safe and secure Bokone Bophirima.

Mothlabane said families, particu-

larly children, should live in an environment unimpeded by the scourge of crime.

"It is driven by the deepest of our convictions that no citizen can ever fully enjoy and realise their freedom, unless such freedom is underpinned by the constitutionally

guaranteed right to safety and a safe environment," Mothlabane said.

Even though crime statistics have shown a slight decrease in contact crimes and sexual offences in the province during the past financial year, the MEC said crime was still a serious concern.

"There is a serious concern due to the increase of contact crimes and sexual offences in the previous year.

"Therefore, a multidisciplinary

approach is still needed to address these crimes. In this case, we will continue engaging our communities and key stakeholders in bringing crime levels down," he said.

The campaign against sexual offence crimes has always been a priority for the province.

In 2008, then MEC Howard Yawa conducted a few workshops which he

said were a part of the department's consultation process to market the strategy to all role players including the private sector, civic organisations and specific interest groups.

Yawa said at least 5295 cases

of sexual crimes were reported in the province, with the South African Police Service highlighting that 41.58% of the sexual crimes occurred on Saturdays and 44.82% between 8pm and midnight.

He said the marketing exercise was intended to raise awareness with a view to eradicate misconceptions around sexual offences, gender-based violence and their causes.

Walking for women, children

Thato Molosankwe is walking from Mahikeng to Klerksdorp to take a stand against women and children abuse

MORE organisations and individuals are coming forward to fight against the abuse of women and children.

Thato Molosankwe, 39, from Lomanyane village near Mahikeng embarked on a walk from Mahikeng to Klerksdorp to take a stand and fight the

"I was molested by a close family friend while I was still young, So I saw it fit to raise awareness against women and children abuse through this cam-

"A three-day walk commenced after we came together as NPOs like Thato Molosankwe Charity Organisation, Women Beyond 2030 and Pelegi Move

"I understand the hardships and tribulations that our people sometimes find themselves in. We have identified those children who are underprivileged and donated food, groceries, blankets and clothes. We also linked them with relevant departments like social devel-

opment," Molosankwe said. He said his Walk against Women and Children Abuse campaign was orchestrated after the killing of Nombulelo Nombewu, 15, from the Jouberton Location in Klerksdorp.

Molosankwe urged other stakeholders to come on board to fight the atrocity. He said socio-economic issues are behind the broken families across South Africa.

"We need to come up with remedial action to address those challenges. We also have an annual campaign in August from Johannesburg to Mahikeng. We also want to applaud other stakeholders like SAPS and Nicsa for taking part. We visited Nombewu's family in Klerksdorp and we will be donating food parcels to them," he said.

Molosankwe said he had to quit his job in Johannesburg to take care of his father after his mother died in April.

Founder of Pelegi Movement Kentse Badirwang said: "Youth empower-ment is imperative and children and young people need to be encouraged to take charge of their lives. I was also raped multiple times and, as a survivor, it is important to share my

experiences.

"We were part of this awareness campaign to educate people, especially men, about the scourge of women and children abuse. We want them to say

#NotInMyName and #EnoughIsEnough. The campaign will spread to other districts across the province.

"We want women to speak out about the abuse they are subjected to before it is too late. We also agreed to raise funds to assist the family of Nombulelo Nombewu who was torched in Klerksdorp a month ago.

"We also call on government to strengthen its policies and bring back the death penalty. Those who abuse and kill women and children must be subjected to death penalty and harsher sentences

Women Beyond 2030 founder Refilwe Boikanyo said they also empowered women spiritually

Boikanyo said her organisation addressed the situations of women and young girls' through empowerment engagements.
"We want them to take action in order

to improve their access to resources and

transform their consciousness through their beliefs, values and attitudes. Women and young girls empowerment aims to improve their quality of life and we can achieve it through participation in empowerment programs.

"However, we are also engaging with other stakeholders to develop a boy child. We cannot continue to capacitate a girl child while ignoring a boy child. Boys need to co-habitate with girls and

not treat them as objects.

"We believe that children's rights implementation should go beyond learning about formal rights and procedures to give birth to a concrete experience of rights," she said.

Meanwhile, the man suspected of murdering 15-year-old Nombewu decided not to continue with his bail application.

Tshepo Manyiki, 32, appeared in a packed Klerksdorp Magistrate's Court on May 29.

It was his second court attendance and he earlier said he would apply for bail. This was something the community vehemently opposed and protested against at his first court appearance.

His legal representative, Kgotso Baloyi, told the court his client wished to abandon his bail application.

Manyiki was charged with murder-

ing the Nombulelo Nombewu whose charred remains were found in an open field at extension 7 in Jouberton on Mother's Day.

The case was postponed to July 31.
The victim's aunt, Vuyelwa Nombewu, said: "We are not happy at all about the outcome of the court because our daughter is dead while Tshepo is still eating and living in a safe place. And we still ask ourselves why he is getting so much protection.

"This is something that traumatised our family and her sisters, the twins Khanyiswa and Khanyisile, who are only 12 years old."

The community protested outside court again.

Hospersa's national youth coordinator Mzukisi Jam said: "Our justice system is failing us because it shouldn't be easy for these perpetrators to gain access to bail.

"I know bail is a matter of human rights, but what about the right to live the victims had been denied.

Jam also blamed political leaders and the South African Council of Churches mostly for not giving much support in these cases.

"There is a need for an organised structure composed of different civil society organisations which will deal with these kinds of issues on a daily basis," Jam said.

The EFF's Dr Kenneth Kaunda regional treasurer, Happy Kali, said they called on law enforcement agencies to speed up these cases. - Newsnote

THE 32 people accused of arson, attempted murder and kidnapping have been granted R500 bail each by the Lichtenburg Magistrate's Court.

The accused from Boikhutso location near Lichtenburg in the North West, were arrested last week on Thursday, after allegedly holding the mayor of Ditsobotla local municipality, Daniel Buthelezi, hostage for eight hours on Wednesday.

They are also accused of setting the municipal offices alight.

Magistrate Mothusi Khumalo said it was in the interests of justice for the accused to be released on bail as the state did not have a strong case.

These were words that brought relief to the accused after spending the weekend behind bars as they had pleaded innocent to the charges of attempted murder, arson and kidnapping.

The temporary municipal workers' defence team had to fight to secure their release.

Their defence lawyer, Gabaiphiwe Mokaa, said their job was to prove that the state did not have strong case and they managed to do just that which is why their clients were released on bail.

Attempts by the state to refuse bail to accused number 19 and 28 failed despite their previous cases.

State prosecutor Moses Segone said the state respects courts of law and would be back after further investigation and by then they hope that this would help to put the suspects back

It remains to be seen what more the state can do to strengthen its case going forward. - SABC

Vavi tells Mbalula: talk less, do more

outh African Federa-tion of Trade Unions (Saftu) general secre-tary Zwelinzima Vavi has taken pot shots at
Police Minister Fikile Mbalula,
saying there should be less talk, jive, rhetoric and shiny suites with bow ties and more action.

He said the minister must instead fix the problems of the workers.

Vavi was addressing about 100 staff members of the police's 10111 call centre, who marched to the police headquarters in Pretoria demanding better salaries.

They gave government seven days to respond to their demands, which include to be upgraded to a

level 7 salary scale (R226 211 p/a).

He also took a swing at suspended national acting commissioner Khomotso Phahlane, saying he was correctly suspended "because he tried to undermine an agreement with former national police commissioner Riah Phiyega".

Wherever you (Phahlane) are, continue playing the music from your R80 000 music system," Vavi said to the delight of the marchers.

In 2013, the 10111 staff met Phiyega and the then Gauteng provincial police chief Lesetja Mothiba who has now been appointed interim acting national police com-missioner – to address members' concerns regarding their salary level at the police call centre.

A task team recommended on the report that the salary level at 10111 should be upgraded to salary level 7, which was also approved by the provincial management and the benchmark report was send to Phahlane for approval.

According to Saftu, a task team

was formed to benchmark 10111 staff salaries against other gov-ernment call centres, including home affairs, SA Social Security Agency, SA Revenue Service, Crime Stop and presidential hotline call centres.

But after the evaluation was completed in October last year, Phahlane said post will be converted to constable post as stated in the Police Act.

South African Police Union deputy chairperson Peter Ntsime said: "The police do not want to take the members seriously and also don't want to come on board at the bargaining council.

"We are now going to give the minister seven days to address the issue and if he fails to do that, we will have to close all the call centres."

Vavi said the police want to convert the 10111 staff from the Public Service Act into the Police

"They will take only those who are below the age of 45," Vavi said.

SAPS 10111 call centre agents march for decent remuneration

THEY are the lifeline that listens to the first call of help from mil-lions of South Africans, but their own pleas for adequate pay for the vital service they provide con-

tinue to fall on deaf ears. SAPS 10111 call centre agents yesterday complained of being ignored when they requested better working conditions. They were marching to the Police Ministry in Pretoria to deliver their complaints. The workers gave the SAPS 14 working days to respond to the demands contained in their

memorandum.
Among the workers was Audrey Sibeko, who said she had to struggle to ensure her family of seven managed to get by on her salary of R8 000.

It was her only source of income, she said. She was the only

one with a steady income in her family and all responsibilities fell on her shoulders.

"With that small salary I have to take care of my father, siblings and my own child who needs a nanny to look after her. I have to deal with all these shortfalls while working a 12-hour-shift which

starts at 3am.
"The investigators came to evaluate the work we do. They too

admitted that for the amount of work we do, we could actually be placed on a higher level," Sibeko

Bethuel Nkuna, who read out a memorandum, said the working conditions at the emergency call centre were distinctly poor, com-pared to other government service

call centres.
"The workers are demotivated because they are underpaid. They are overworked, and they experience dangerous stress levels because of these working condi-tions," he said. "We call for solidarity from

police officials, to decline this divide and rule strategy from the divide and rule strategy from the SAPS. We will ultimately call for solidarity from the general pub-lic. Our mothers, fathers, brothers and sisters – if this challenge is not dealt with swiftly and accord-ingly, we will close down 10111 across the country."
