Bidders are required to complete the preference claim form (SBD 6.1), and submit their original and valid B-BBEE status level verification certificate or a certified copy thereof in order to claim the B-BBEE status level points.

The points scored by a bidder in respect of the level of B-BBEE contribution will be added to the points scored for price. **Bidders are required to provide certified copies of the shareholders identity documents and proof of company registration where it is applicable. Failure to comply will invalidate your offer.**

The State may, before a bid is adjudicated or at any time, require a bidder to substantiate claims it has made with regard to preference.

In the event that two or more bids have scored equal total points, the contract will be awarded to the bidder scoring the highest percentage of preference points for B-BBEE. Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots. **In the event of a Joint Venture a consolidated BBBEE STATUS LEVEL verification certificate in the bidding entity's name should be submitted with the bid. A Joint Venture Agreement attested by a Commissioner of Oath should be provided failure to comply will invalidate your bid.**

The Department of Social Development reserves the right to award bids detailed above in whole or in part and does not bind itself to accept the lowest or any bid.

TAX CLEARANCE CERTIFICATE

An original and valid Tax Clearance Certificate issued by the South African Revenue Services certifying that the taxes of the bidder are in order must be submitted at the closing date and time of bid.

Failure to submit the original and valid Tax Clearance Certificate will result in the invalidation of the bid. Copies and/or certified copies of the Tax Clearance Certificate will not be acceptable.

VALUE ADDED TAX
