It has come to our attention that there are licences purported to have been signed by the MEC, for Finance, Economy and Enterprise Development Ms. W. Nelson and are fake licences which are in circulation in the province.

For purposes of verification and to update our system during the renewal period of 2018/19 the licence holders are required to bring the following:

- 2017/18 renewal licence (form 22) accompanied by original identity document of the licence holder.
- In an event of any licence with section 38 approvals by the board, such approval must also be accompanied by the original identity document and 2017/18 renewal.
- In an event of section 39, we require the identity document of the licence holder and that of the appointed manager as well as the approved letter of appointment by the board.
- Letter of authority/executorship/administrator/curator, copy of 2017/18 renewal, original identity document of the appointed person, in cases where the licence holder is deceased.

**NB: Due to the fraud that has been identified, the Department requests that all renewals must be done by licence holders only.**
