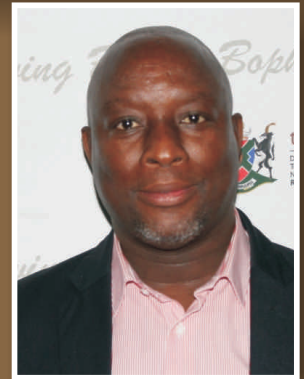
**Dr. Nkagisang Monyane Gabriel**
